- (b) Service to the Institute – education and creating awareness of the role of PIPSC Stewards in the Work place; active participation in branches, executives, general Institute activities etc.  
- 50 of 100 points
- (c) Service to fellow members – participation in OSH, LMRC etc.  
– 30 of 100 points
